- 19. Nature of projects adopted in the year 2016-17 :
  - (a) Rural roads development.
  - (b) Construction of bridges and culverts.
  - (c) Renovation and development of educational institutions such as- College, high school, madrasha, moktob, primary school etc.
  - (d) Renovation and development of different structures of ZP Netrokona.
  - (e) Development of social and cultural institutions such as- common library, club, Samity etc.
  - (f) Renovation and development of Eidgah, graveyard, Cremating ground etc.
  - (g) Distribution of tools relating to ICT and training.
  - (h) Repairing and development of mosque.
  - (i) Development of shrine and makeshift houses.
  - (j) Repairing and development of temple.
  - (k) Development of health and medical service infrastructures.
  - (1) Construction and repair dakbanglows for entertainment of govt. and non-govt. guests.
  - (m) Building Auditorium.
  - (n) Human resource development, women empowerment, poverty alleviation etc.
- 20. Zila Parishad : Adoption, approval and Implementation procedure of development projects:
  - Annual development projects(ADP) are adopted in the Zila Parishad monthly meeting. Later on those need to be approved by the local government division. Projects estimated amounting to taka more than 2.0 lacs are implemented through tendering and quotation process following PPR. Projects amounting to the estimated cost upto tk 2.0 lacs are materialized by PIC (Project implementation committee). It's to be mentioned here that no project lower than estimated cost of tk 1.00 lac is adopted by the ZP. It is also notable here that projects under PIC shall not exceed 30% of the total estimated cost of ADP. Project proposal from own fund of Zila Parishad is adopted in the Zila Parishad meeting and the local government division gives approval to it as usual. If the amount of these projects are more than tk 2.0 lacs those are implemented through tendering process and if it amounts to lower than that it is materialized by the project implementation committee.
